RE: Agricultural Operations Survey – Stage 2 of the GTA West Transportation Corridor Planning and Environmental Assessment Study

The Ontario Ministry of Transportation (MTO) is undertaking Stage 2 of the Environmental Assessment (EA) Study for the GTA West Transportation Corridor. Building on the recommendations from Stage 1, the EA Study will identify the route, determine interchange locations and complete the preliminary design for a new transportation corridor within the Route Planning Study Area. The new transportation corridor will include: a 400-series highway, transitway and potential goods movement priority features.

Public and stakeholder consultation continues to be a key study component of the study – with diverse and multiple opportunities to be involved in meaningful and substantive ways. Discussions with the public and other stakeholders are focusing on data collection; the generation of alternatives; the assessment, evaluation, and selection of the preferred alternative; and the development of mitigation measures to reduce or avoid potential environmental impacts.

With this in mind, and based on comments received from the agricultural community, the project team is undertaking additional consultation with agricultural land owners and agricultural land users. In an effort to determine the extent of the diverse agricultural land uses, farming practices, and linkages to other properties, an Agricultural Operations Survey has been created.

We invite all agricultural land owners and agricultural land users to review the enclosed Agricultural Operations Survey, provide a response to the specific questions, and return the Agricultural Operations Survey to the project team as indicated on the survey.
